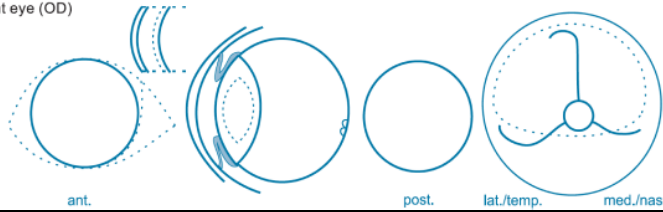

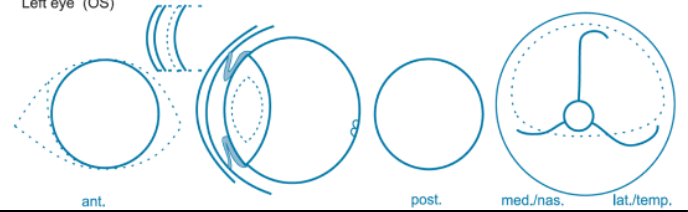

Further development will confirm the diagnosis.
